## Rates for Seasonal RV & Park Model Sites Rates Effective April 1, 2022

**IMPORTANT: Seasonal rates apply only if a Seasonal Agreement has been signed & approved.**

**Seasonal agreements & last month's rent due April 1.** Non-renewals must vacate by March 31.

**Standard RV season is May 1 to October 31.** Bathrooms open May 1 - Oct 31. Campground open April 15 - Nov 15. Special permission is required to occupy RV's before April 15 or after Nov 15.

**Seasonal rate covers occupancy for up to 6 months.** Additional rent is charged for any additional month or fraction thereof in which unit is occupied for more than 2 nights.

**Rates include** water, sewer, household trash disposal and recycling.

**Rates do not include** electric, gas, cable, yard maintenance, taxes or phone.

### PAYMENT OPTIONS:

- **SEASON PREPAY:** A **\$25 discount** applies if entire season is paid in full by April 1.
- **MONTHLY PAYMENT SCHEDULE:** If you choose to pay monthly, payments are due on the 1<sup>st</sup> of each month from April 1 thru September 1.
- **NOTE:** If you complete an agreement after April 1, all payments up to and including the date of application are due. Prepay discount is not available after May 1.

### ADDITIONS TO RENT

**CREDIT CHECK FEE:** Park models & Mobile Home applicants are charged a one time fee to cover cost of credit, rental & criminal background checks. Fees are **non-refundable and due with application.**

**APPLICATION FEE: Seasonal RV's only: First time seasonal RV's** are charged a one time **application fee of \$50.** Fee is non-refundable. Fee is due with application and is in addition to lot deposit.

**DEPOSIT:** One time **\$50 deposit** due with first month's rent. Deposit is held until site is permanently vacated and will be refunded after all outstanding charges to your account have been paid, as explained in the seasonal camping agreement.

**METERED ELECTRIC:** Sub-metered sites are read and billed monthly on your statement.

**SPECIFIC TAX: \$ 3.00 per month.** (\$18 per season) Collected year around on manufactured homes, park models and unlicensed RV's during each month your unit is located on a site for 15 or more days. RV's displaying a valid license plate are exempt.

**LATE PAYMENT FEE:** **\$30.00** for rents received after the 10<sup>th</sup> of each month.

**NSF CHECK FEE:** **\$35.00** per occurrence.

**VIOLATION NOTICE FEE:** **\$25.00** per occurrence (see Resort Guidelines).

**RESALE INSPECTION FEE:** **\$60.00** Required for park models & homes when inspected for resale.

**Internet, Phone & Cable TV** is available from Comcast for additional fees & connection charges.

**Personal Property Tax:** *You may also be assessed a "Personal Property Tax" for leasehold improvements on your site. The township will notify you directly of any assessments. Taxes due in Sept. and February.*

**FENCED STORAGE SPACE:** **Residents: \$ 54.00 per year or fraction thereof.**  
*Billed at time of registration and annually in October for following year or fraction thereof.)*  
**Non-residents: \$ 40.00 per month** (space permitting)

**MINI-STORAGE: Resident use only.** Contact the office to be placed on waiting list if interested.

<b>PETS:</b>	Second Dog (grandfathered pets only)	\$15 / month (2nd dog may not be replaced)
	Visiting dog registration fee	\$15 / year - 30 day annual limit.

**TRASH DISPOSAL:** Rent includes your Resort household trash disposal only. No construction debris without permission. Anyone bringing trash from another residence or belonging to a nonresident will be charged & given a violation notice. Do not cause dumpsters to overflow. Please contact the office for information.

**YARD WASTE:** Curbside pickup of bagged yard waste, sticks, etc. is first thing on Monday & Thursday mornings only. Place in yard beside curb. Do not pile in street or on sidewalk.

- **Leaves/clippings for compost:** take to compost pile or bag for curbside. Organic material only!
- **Tree brush, heavy garden waste:** take to burn pile. No shingles, furniture, insulation, lumber, etc.
- **No construction waste:** Carpet, roofing, drywall, scrap lumber, siding, etc. **must be removed from park**

**RECYCLING:** Rinse & sort only items listed on flyer. Flatten cardboard. **No Styrofoam. No plastic bags!**

### PROHIBITED ITEMS:

**USED MOTOR OIL, ANTIFREEZE, etc are NOT ACCEPTED!** Take to an oil change shop for recycling.

**NO TV's, computer equipment/monitors, water heaters, appliances, refrigerators, freezers, air conditioners, tires, upholstered furniture, mattresses, auto / marine batteries, rechargeable batteries, propane tanks, metal gas cans.**

**NO HAZARDOUS WASTE: This includes antifreeze, pesticides, poisons, gasoline & all oil-based products.** It is your responsibility to arrange for their safe, legal disposal. Anyone putting hazardous waste in trash, sewer, recycle area, ground, lake, or storm drains will be liable for cleanup costs & prosecution.

**SEWERS & DRAINS: DO NOT flush or put down the drain:** baby wipes, rags, cleaning wipes, disposable toilet brushes, hemorrhoid wipes, tampons, sanitary pads, panty liners & pads, medical dressings, medications, latex gloves, condoms, diapers, towels, paper towels, kitty litter, underwear, coffee grounds, cooking oils, etc. **Even if it says "flushable," do not flush!** Dispose of these items in the trash.

**NO GARBAGE DISPOSALS: Do not put cooking oils or food waste down the drain!** Place in compost or trash.
