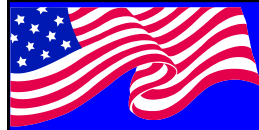

Annual Notice Regarding Davis Drive

“A Court Order was entered in the St. Joseph County Circuit Court which limits the use of Davis Drive to the owners of lots in Summer Haven Subdivision and/or their guests or invitees. Residents of the Resort shall not use Davis Drive for ingress and egress to Klines Resort or for recreational purposes, and may only use Davis Drive if they are guests or invitees or a lot owner in Summer Haven Subdivision.”

Davis Dr. is the dirt lane that runs along the Resort’s north property line. This notice is an annual requirement of our agreement with several of our Davis Drive neighbors. Please respect their desire for privacy. Should you encounter problems with any of these neighbors, please do not confront them and report the incident to the office.
